High Expectations



Attendance

LECB have very high expectations regarding learner attendance. We expect that you will attend all timetabled lessons on time and ready to learn whether they are in the classroom, in another venue, or online. This is because learner absence is one of the major factors which contribute to learners not reaching their full potential.

Excellent attendance helps to prepare you for your future; it is a key employability and life skill. Your overall attendance may also be used to assess your eligibility for some bursaries and additional support.

As an adult learner, it is not uncommon to have to balance your studies with other commitments including paid employment and caring responsibilities. It is important from the outset that you have a firm plan in place to allow you to attend fully, with a back-up plan in case things don't go as anticipated.

Not meeting with the college expectation for high attendance could result in disciplinary action and your withdrawal from the course.



Holidays

Please refer to the calendar of key dates provided at enrolment so you can avoid planning holidays during term time. Any holidays taken in term time will lead to disciplinary action.



Routine Appointments

You should not make routine appointments for personal matters (e.g., a visit to a doctor or a dentist – for yourself or a dependant) during lesson time. These must be arranged outside of the college day wherever possible.



Absence Reporting

Should you be unavoidably absent from college, you should ring 020 3045 5176 on each day of absence. Your reason for non-attendance will be recorded.

No other means of notification, including emailing teachers directly, should be used as an alternative.

If you are absent due to a medical or legal appointment, you will be asked to provide supporting evidence so that the absence can be recorded as authorised.



ID badges

Learners must always visibly wear their ID badge when on college premises. Learners will not be permitted access to the College without their learner ID badge displayed. If you forget your badge you must report to reception where a temporary badge will be given to you. If you lose your ID badge, a fee for replacement will be incurred.



Dress Code

Learners must wear clothes which are appropriate for a learning community. When in college we ask learners not to:

- wear clothing which will likely causes offence to others (e.g., clothes that are too revealing or display offensive slogans or images).
- wear clothes which could interfere with teaching and learning or to pose a risk to health and safety (e.g., a garment, hood, or head gear, which covers up the face).



Mobile Phones

Learners must keep their mobile phones off or on silent during lesson times. Under no circumstances should phones be answered in class. Should you have a personal emergency, inform your tutor before the start of the lesson or at the first available opportunity.



Smoking and Vaping

Smoking or vaping is not allowed in any college building or grounds including car parks.

Celebrating Diversity

We are committed to ensuring that everyone can participate in learning and are proud to have a diverse cohort of learners and staff.

Learner Charter

We will provide:

- Your voice heard through 3 learner surveys per year, termly learner forums, class visits, and suggestion boxes.

We expect learners to:

- Arrive punctually and ready to learn at the published start time of all lessons.
- Always follow staff instructions.
- Take ownership of your own learning by assessing your own progress on the course.
- Be fit to attend college and not under the influence of alcohol or drugs.
- Raise any concerns you have about your learning and progress.
- Be aware of and abide by policies and procedures.
- Be responsible for personal health and safety.
- Be respectful and tolerant of staff and other learners.
- Dress appropriately and visibly wear your ID card.
- Ask for the support you need to allow you to participate fully and achieve.
- Make us aware of any circumstances that may prevent you from fully participating and/or hinder your achievement.



Learning Support

When you apply for a course at the College, you will be asked about any physical disability, learning difficulty, disability, or health conditions that you may have. This information helps us identify if you need support and if so, what the most appropriate support is. Our Disability Statement gives details of the support we can offer and can be found on our College website or ask at reception.

Even if you have never experienced any learning difficulties before, you may still seek advice if you are struggling with the course work. First speak to your tutor to discuss your difficulties and if your tutor agrees that you may benefit from additional support, either you or your tutor can contact the Learner Support Manager.

For those learners who are accompanied by a Personal Assistant or Carer, we have an additional leaflet outlining our guidelines.

Accessibility and Accessibility Aids

If you have dyslexia, you may require reasonable adjustments on your course. For example, worksheets copied onto coloured paper or use of a laptop. You may also qualify for access arrangements such as extra time or rest breaks in exams.

College Learner Survey

We send out three learner surveys in the year, which look at your entire learner experience within the College and particularly look at the wider impact of learning with us.

It is essential for us to receive your honest feedback to implement the relevant changes or improvements.

London Learner Survey

In addition to our own surveys and evaluations, a London Learner Survey gets issued by the Greater London Authority. It is crucial for our learners to complete the survey as our funding depends on it, your tutor will support you with it.

Learner Voice Forums

The learner voice forums take place each term and are open to all learners. The forums are facilitated by the CQMs and can also be attended by the Quality Manager or SLT members on occasion. They provide an opportunity for learners to voice their opinions about their course and the college and receive a response.

You Said-We Did

You Said-We Did is a way for us to inform learners of the actions we have taken based on what they've told us in the surveys, forums, class visits. Under the form of a poster, the You Said-We Did is emailed to tutors and displayed around college.

Class Observation and Learner Voice

The College Observation Team will perform class observations and Learning Walks throughout the year. During a class visit, we may ask to speak to individuals or to the whole class to get feedback on what is going well and what could be improved.

Health & Safety

You must adhere to the H&S guidelines as directed by the tutor or a member of college staff.

Fire Drills/Evacuations and Lockdown

Fire drills are held termly, and an alarm test is held every Tuesday at 10.30am and lasts for approximately 30 seconds.

Please make yourself familiar with the nearest escape route and the designated assembly point.

Evacuation plans are displayed in prominent positions around all College sites. Please be aware of emergency procedures and fire exits.

If you have a disability, please contact the Learner Support Manager so that we can arrange a Personal Emergency Evacuation Plan (PEEPS)

In the event of a lockdown an alarm will sound, please follow directions from your tutor or staff member where you should remain and do not leave your area unless directed by a member of emergency services or staff member.

First Aid/Mental First Aid

If you need first aid the college has designated first aiders, ask reception or any member of staff.

Incidents and Accidents

All incidents and accidents must be reported to any member of staff so that they can be recorded.

Medical Fitness

Learners must ensure that they are medically fit before enrolling on a course, which involves physical activities. Learners undertake such courses at their own risk and are required to complete a declaration of fitness at their first session. A learner may be prevented from participating in the class until the GP consent has been received.

Digital Skills, Online Learning and E-Safety



Online Learning

We recognise the benefits and opportunities which digital technologies offer to teaching and learning. We also recognise the risk these technologies can pose so do all that we can to make our learners and staff stay 'e-safe' and satisfy our wider duty of care.

It is important that learners understand how to stay safe while using and accessing information, and the risks that can be involved in using technology.



Office 365

All learners will automatically have an LECB Office 365 Account. Your Tutor will give you your username and password during your course induction.



Email:

All learners will be provided with an LECB e-mail address. We expect learners to use their college e-mail address rather than private e-mail addresses for communication about college matters.

You are expected to regularly check your e-mail inbox for communication from the College. If you choose, you can set up a divert from your college account into your private account.



OneDrive:

You will have access to OneDrive, where you can safely and securely store your college work. This can be accessed anywhere, on any device.



Teams:

All classes automatically have a Team set up. Your Tutor will set homework, post messages to the class and you can also communicate with other learners in your class.



e-Safety

e-Safety includes all internet technologies and electronic communications such as mobile phones, games consoles, and wireless technology.

Learners are expected to behave responsibly online and follow the college e-safety policy. The college IT Acceptable Usage Policy which contains full conditions for using College IT facilities is available on request.

To stay safe online you must:

- Use the internet and social media responsibly
- Avoid sharing personal information
- Use strong passwords and do not share your password
- Never save your password or personal details on a public PC or laptop

When using technology at the learning centre do not:

- Access, display or download any offensive or extremist material
- Use or display offensive or abusive language
- Use unauthorised material

Your tutor will help guide you on how to stay safe when using technology and let you know how this relates to your course.

Safeguarding and Prevent

At LECB we have a team of trained professionals to keep you safe and well. Our aim is for all our learners to feel that they can come to college learning free from bullying, harassment, abuse of any kind, discrimination or victimisation. We have a duty of care for children, young people, and vulnerable adults. Vulnerable adults include anyone over the age of 18 years who may need community care services because of mental or other disability, age or illness or somebody may be temporarily vulnerable due to factors such as divorce, bereavement, addiction, or financial difficulties.

If you have a concern either for yourself or another learner, please talk to your tutor or a member of the safeguarding team. We can help.

Concerns may include:

- Domestic abuse
- Abuse (emotional, mental, sexual, physical, or financial)
- Bullying or harassment
- Neglect
- Online safety
- Exploitation (sexual/modern slavery)
- Sexual harassment
- Radicalisation or extremism

Prevent

Prevent is part of the UK's counter-terrorism strategy, preventing people from people becoming involved in terrorism or being radicalised.

Prevent is safeguarding. In the same way that support is provided to people at risk of involvement with anti-social behaviour, gangs, drugs or other forms of harm, individuals vulnerable to being groomed into radicalisation can also be helped. Radicalisation can happen when a person becomes exposed to extreme ideologies, which may be founded in social, religious, or political beliefs that seek to undermine society and choice.

This may result in individuals or groups being encouraged to take part in violent or extreme actions or joining groups, which promote these. There are some tell- tale signs of possible radicalisation:

- Secretive behaviour about online viewing
- Extreme 'them and us thinking'
- Social isolation
- Holding very strong views and being unwilling to listen to other points of view
- Promotion or distribution of extremist content
- Change in physical appearance and dress
- Change in aspirations, routines, and travel patterns

Prevent aims to work with people who are vulnerable to extremist views and supports them by using voluntary early intervention to encourage them to challenge extremist and terrorist ideology and behaviour, to help stop their further engagement in extremism.

Fees and Funding

The Learning & Enterprise College Bexley is funded through a variety of channels but most notably the Greater London Authority (GLA) and the Education and Skills Funding Agency (ESFA).

Some courses are fully funded such as English and maths and others partly funded. Apart from a small number of full cost courses, courses whether leading to a qualification or not, are at least part-funded by the GLA/ESFA and therefore get quality monitored by the Office for Standards in Education (Ofsted).

This brings with it certain requirements such as completing enrolment forms, supporting learners using Individual Learning Plans, emphasis on punctuality and attendance and so forth.

Help With Fees

There is assistance available for accredited courses for eligible learners from the following funds:

16-19 Bursary

Available to learners under 19 and those who have an Education, Health, and Care Plan (EHCP).

These funds can be used for things like:

- clothing, books and other equipment for your course
- transport and lunch on days you study or train

Learner Support Fund

Available to learners 19+ on accredited courses and facing financial hardship.

Learner Support can help pay for things you need to attend your course or study that are not covered by your course fees.

The money could help with, for example:

- travel costs
- accommodation
- materials and equipment
- a laptop and wifi
- childcare with an Ofsted-registered childcare provider

Advanced Learner Loan

Funding for Level 3+ courses for learners aged 19+ to for help with course fees. Advanced Learner Loan - How to apply

Advanced Learning Loans Bursary Fund

Available to learners 19+ who have taken out an Advanced Learner Loan. The bursary is not available to Learners who have paid their own course fees. for help with travel, childcare, books, equipment, and materials.

College Bursary Fund

Available to learners on non-accredited courses who can demonstrate financial hardship and that attendance on the course will improve their wellbeing. The fund can assist with course fees and equipment. Funds are limited and the College regrets it may not be possible to fund all Learners who meet the criteria.
